- Jurisdictional issuances – from emission reduction and removal projects conducted at a national or sub-national level – **present the opportunity for future large-scale issuances which will help develop greater supply of high-quality credits**
- Jurisdictional credits are set to play a key role in international compliance markets **such as CORSIA and Article 6**, making them a valuable credit type for achieving global targets
- Nevertheless, the transition towards jurisdictional programs **can create significant risks to individual projects due to ‘nesting’**, which means VCM buyers need to understand, evaluate and monitor portfolio exposure

JREDD+ Country Assessment

Outlines countries’ REDD+ landscape and assesses the viability of investing in JREDD+ programs based on how prepared a country is to implement JREDD+ programs and the potential risks associated with it. Also, it provides relevant information for those that currently hold individual REDD+ projects in their portfolios and face jurisdictional transition risks (such as ownership risks and rebaselining and nesting). The thirty most active countries in the JREDD+ space are included in the assessment and a comparison among all of them is provided through a scoring system.

Provides an overview of the current state of the JREDD+ standards (including for example market acceptance and reputation) and methodologies and monitors its evolution. It meticulously breaks down the ART TREES, VCS JNR, FCPF Carbon Fund and REDD.plus methodologies comparing how each of them approaches key aspects that define the quality of a carbon credit (such as additionality, leakage or co-benefits) and highlighting any red flags or loopholes that could be exploited.

Also, it assess overlaps among different programs to identify potential double issuance risks and tracks jurisdictions participation in the LEAF Coalition.
